## 2023 DeVry University New York Climate Survey Results

#### **Response Rate**

54, or approximately 2.4% of the student population surveyed, responded to the Campus Climate Survey (Survey) and all 54 students completed the entire Survey. The surveyed population included students that took at least one course at the Midtown Manhattan, NY location over the last three (3) sessions, and any student residing in New York.
